August 29th : Selection date for the jury (to be
confirmed)

September 17th : notification of acceptance will be
mailed with information concerning shipping,
delivery and pick-up of the selected works.

November 3rd : hand-delivery from 10am to 1pm.

November 5th: Opening reception, 6pm to 9pm.

November 14th : take-down and pickup of
paintings **from 5pm only, after store closure.** Be
sure to arrive before!

CRITERIA

- Open to all members in good standing.
- All subjects and styles are accepted. The maximum size with frame (vertical or horizontal) is 45 inches (115 cm)
- Medium : dry pastel for a minimum of 90% of the painted surface. No oil pastels or mixed-media.
- **Original artworks only :** copies or compositions made from published photos or done under a teacher's supervision are not accepted.
- Works already exhibited with PSEC are not accepted.

CONDITIONS

- You may submit 3 works for the selection and all 3 may be accepted.
- PSEC will retain a 25% commission on all sales. All works must be for sale and your price must include the commission. Price your work accordingly. No change of information and no withdrawal of works will be accepted.
- All reasonable precaution will be taken with your works, nevertheless, La Maison Ogilvy, or PSEC, or it's volunteers will not be held responsible for any damage, theft, loss or fire occurring while the works are under our surveillance. Insurance is at your own discretion.
- PSEC will retain digital images of accepted works for it's archives and may use them for publicity,

catalogue, CD, magazine, website, gallery presentations, etc

- Upon delivery, PSEC reserves the right to withhold any painting which does not correspond to the image submitted to the jury or does not meet the above criteria. No substitution of paintings will be allowed.
- Your *SIGNATURE* on the form constitutes your agreement with all the above criteria and conditions.

PROCEDURE : DIGITAL IMAGES

1. The selection will be made from digital images presented on CD only. No e-mailing of the images will be accepted. Your slides may be scanned, digitalized and put on a CD at any good photo shop. Have them identify the digital files with your last name and title. Ex: PICASSO, Simplicity.jpg
2. All images must be in **JPG (jpeg) format only**, compatible with PC. No other format will be accepted.
3. The artwork alone should appear on the screen, on black background, no frame, no mat or identification on the screen; the selection is done anonymously. Maximum of 3 images on the CD and **nothing else**.
4. Resolution of **300 dpi**, minimum.
5. Weight of files: between **500 Kb** and **3 Mb**
6. Clearly **identify** the CD and the case. The **digital files** must be identified with your **last name and title**.
Ex: PICASSO, Simplicity.jpg
7. **Include a good quality paper printed photo** approximately 4x6 inches (10x15cm) for each work. **Identify** each picture on the back with name, title and **signature**. Your signature certifies that the image is as close as possible to the original work. (The photo serves as reference for adjusting computer screens.) Work that does not correspond to selected images could be refused upon delivery.
8. CD's and photos will not be returned but will be available at the show.
